We Heart Seattle is an action-based, boots-on-the-ground movement that organizes trash cleanups in our public spaces and offers resources to those in need. Through our direct civic engagement we lead the way to a more compassionate and healthy community.

**Form 990, Part III, Line 4a - Program Service Accomplishments**

In 2024 We Heart Seattle (WHS) removed 315,000 pounds (157 tons) of trash from Seattle's and bordering cities, public spaces (parks, alleys, sidewalks, playgrounds, greenbelts, bike trails, vacant lots, and commercial zones), organized 60 individual debris cleanup events and accrued close to 4500 volunteer hours. Through our civic engagement, we involved 380 new volunteers, restored 31 degraded landmarks and parks, and partnered with park stewards who maintain these spaces long-term. Our organized large format debris removals not only contribute to a cleaner environment, but also foster system-wide changes for equity and civic engagement by bringing communities together. In 2024, we further supported civic engagement by hosting a city-wide voter awareness walkabout, along with voter registration and education events. During our daily boots-on-the-ground activities, we connected individuals living unhoused to a range of vital resources, including recovery, housing and employment navigation, securing vital documents, removing a range of barriers and, ultimately, assisting 48 individuals to move off the streets in 2024. Our Clean and Care model provides a unique and vital approach to saving lives, thus saving our city from the decimation the drug epidemic plays in the environmental and humanitarian crisis we face. In 2024, We Heart Seattle formally partnered with the City of Seattle to access a drug rehabilitation fund providing friction-free access for people in need of treatment.
